
Overview

The HDPM6000 I/O Module is built on the HDPM6000 platform technology and is available to add digital and analog inputs, as well as a digital output to the connected system.

Powered by the HDPM6000 platform, the I/O Module provides two digital inputs, one analog input (10 VDC), one relay output and one CT input. The HDPM6000 head unit outputs data directly to your network and the analog/ digital points can integrate with any BMS or DCIM system via Modbus TCP/IP, SNMP and BACnet/IP.

The HDPM6000 I/O Module is ideal for large critical and non-critical building applications such as data centers, industrial facilities, infrastructure and other similar environments.

Mounting


The I/O module should be mounted inside an enclosure or panel. The I/O module receives its power, voltage, reference and communications via a straight-through CAT6 cable that is connected to one of the RJ-45 connectors on the I/O module and the bus port on the HDPM6000 head unit or one of the other downstream devices supported by the head unit.

Note: CAT6 cable must be <30 m (98 ft.) in length between the HDPM6000 head unit and the first module on the bus daisy chain.


Align CT arrow to point in the direction of the power flow.


Each CT can be connected to a circuit by opening or removing the top of the CT and snapping it onto the wire that connects the power source to the load. The CT label must face the power source. Ensure that the CT is closed tightly or readings provided by the HDPM6000 head unit may be affected.

Split-Core Models


For this model CT, the arrow indicates the current flow (i.e., the label faces away from the circuit breaker).

CTs may be simply hung on the wire which they snap around. An alternative is the use of VELCRO® strips on the bottom or hinged side of the unit, to allow for ease of mounting and removal as necessary. VELCRO is non-conductive.

NOTICE

CT WIRE MISCONNECTION

- Connect white CT wire to the connector port closest to the RJ-45 connector.
- · Connect black wire to second CT input.
- · Paired lead wires must be kept together.
- Do not install CTs in a panel where they exceed 75% of the wiring space of any cross-sectional area within the panel.

Failure to follow these instructions can result in loss of data and damage to equipment.

Each CT output has two wires. The white and black lead wires from each CT are associated with specific ports on the I/O module. Connect the white lead wire to I1+ and the black lead wire to I1-.
